Meeting Notes:

- Welcome from Dyness and Introduction of Steve Ollis, Chair of subgroup
- Subgroup member introductions
 - Subgroup members introduced themselves via audio and chat.
- Discussion of TOR:
 - Roles and responsibilities
 - The role of the subgroup fits in well with the broader goal of the CH TF of advocacy and being a knowledge management platform to share information and learn from each other.
 - Goals and objectives
 - Members expressed specific interests they had for the goals and objectives of the subgroup such as:
 - Helping influence the guidelines for WHO to ensure digital tools are included for community health workers as they work with children.
 - How tools for frontline health workers fit into larger country health information systems and issues of interoperability.
 - WHO standards of care are usually very focused on specific health components. It would be helpful to discuss how digital health tools or interoperability could support these new standards.
 - It may be good to keep an active list from the different organization of who is working on any innovations, technologies, or digital.
 - Need to consider what groups already exist and what is the value add of this subgroup.
 - One suggestion is to first identify the problem that may require an innovation or digital solution. Is there a specific problem that we're trying to solve?
 - Feel that across innovations and digital there is a lack of information out there on what is going on, what is appropriate, what are some of the considerations, what others are working on, what are the costs, pros and cons, etc. Difficult to find this information while it is happening. This group could play a role in this.
 - Groups or individuals that would be able to contribute to the objectives of this group? Or resources for the group?
