Looking to launch study on iCCM underutilization in 3 countries: DRC and Senegal and one more country (TBD).</li> <li>Colin: In Burkina Faso, he attended a "Best Practices in Health" meeting sponsored by ECOWAS. The theme focused on best practices in RMNCH – several presentations on scaling up and iCCM projects in West Africa. WAHO website contains more information. He also had a chance to meet with Burkina Faso MOH – through the new Global Fund grant, they will be scaling up their program to three additional regions. The program will pay CHWs (\$40USD/month). The CHWs need to be 5k or more from the nearest health facility. The CHWs will be operating in the Sahel, which has some of the worst health outcomes in the country. CHWs and volunteer programs are often not paid – want to find a way to operationalize this so they are paid an incentive package and are able to use mobile technology.
