General Updates	 Nick Oliphant who was the M&E Subgroup Co-chair has moved to the Global Fund. Kate Gilroy from MCSP will now take on the co-chair role for the next couple of months. We are hoping to get more information from UNICEF to see who will replace Nick for this subgroup. We are following up with them and will update the Subgroup once we have more information. In 2017 we are aiming to get more involvement from other organizations to learn more about what work other organizations are carrying out. We will reach out over email to identify that someone from each organization can work with us on the agenda to share some of the details on the work that they are doing that is relevant to this group. If Subgroup members could bring in two more people from each organization to reach out to our colleagues we could get broader 	
Update on the indicators and next steps	 We were working to refine the list of indicators that were recommended for iCCM. The team reviewed the indicators and identified from various perspectives to see what the needs would be. We are now reviewing evidence from programs on what worked and what would be feasible. The list of indicators has evolved through this process and a smaller group was identified to develop reference sheets with these indicators. The current list is 10 indicators. We will circulate this list after the call. The current list of indicators to the core group and got their feedback in mid-December. They are close to completing the draft of the reference sheets. 	 are hoping to share this in the coming weeks for wider review and input. Once they are finalized and received everyone's input there will be discussion about how to circulate them more broadly. We will try to identify opportunities to disseminate at country level. Kate will take care of the revisions and send out to the smaller group. The Global Fund has a contract with University of Oslo to make DHIS2 guidance for community based information system to look at DHIS2 modules. These routine indicators that we are suggesting could be the starting point for University of Oslo. Indicators are a perfect input into that effort for the community module. 	
Update on MCSP Work	 The MCSP team is conducting a review of CCM indicators based on community health information systems across 23 countries. We are looking at what countries are collecting i.e. if they are collecting at facility and community level to see what's on the forms and aggregate forms. We are examining what information countries are collecting to better understand and identify what is making its way up into the aggregate systems. We aim to identify common themes and gaps across countries as well. We will also be identifying how the community health information system is configured or flowing into the HMIS/DHIS system since this varies by country as well. We are looking to compliment that with the deep dive review of each element. HRH indicators are more difficult to collect because many aren't reporting on how many CHWs they have. There are a few countries that are capturing human resource indicators including DRC. MCSP has held internal discussions and it is in our workplan to hold a regional workshop with some countries. The priority is to try to combine this workshop with another regional workshop or conference. We hope to build on the HMIS review once it's complete to work with countries to strengthen or test indicators.
