Meeting Notes:

- Subgroup objectives:
 - \circ $\;$ The TOR has been revised and shared with members.
 - Advocate for the development of nutrition within iCCM and community packages both in policy and practice, including leveraging funding for this work
 - Are we thinking about addressing all four typologies, or continuing to focus on SAM?
 - Members agreed to open up all 4 typologies
 - Collate and disseminate evidence on the integration of early detection and treatment of malnutrition into community platforms e.g. iCCM and IMCI
 - Is it community IMCI, or community and primary healthcare IMNCI?
 - Main objective is to strengthen nutrition interventions.
 - We need to link the language to global themes.
 - Focus was on collating evidence in community platform
 - Scale-up efforts on the promotion and support for early and exclusive breastfeeding.
 - Narrowed it down to breastfeeding should it be broadened, expand to ENA?
 - Members decided it will continue to be focused on early breast feeding and it will need to focus on both community and facility level.
 - Need to decide who the intended audience is for this objective
 - Suggested language: "coordinate and support partners' (subgroup members and others) efforts to scale-up promotion of early and exclusive breastfeeding (in priority countries)"
 - Facilitate the sharing of best practices from countries that have successfully integrated ECD and nutrition interventions at community level.
 - ECD would need specific indicators/parameters to determine best practices.
 - This is essential for activity development, particularly in determining results of activities.
 - Opportunities for integrating ECD/nutrition are broad, so best practices will look different depending on the context, age group, etc.
